## FY 2018 Disproportionality Analysis

Pursuant to DFPS Rider 14 of the 2018-2019 General Appropriations Act, 85th Legislature, the Department of Family and Protective Services (DFPS) provides information on the racial and ethnic breakdown of children within the seven largest counties in the state, who are reported to the Statewide Intake Division. This breakdown highlights any disproportionality that may occur within Harris, Dallas, Tarrant, Bexar, Hidalgo, Travis, and El Paso Counties<sup>i</sup>.

### Analysis

The analysis uses the Origination Disparity Index (ODI) for African Americans, Hispanics, and others. Overall, disproportionality was most pronounced for African American children. Although there was some localized disproportionality for every race and ethnicity, the general nature, extent, and magnitude differed.

Based on statewide data collected in FY2018, African American children are 1.7 times more likely to be reported than Anglo American children. This had been rising steadily every year from 1.5 times more likely in 2013 to 1.7 times more likely in FY2017, before remaining unchanged at 1.7 times more likely in FY2018. The same pattern can be seen in the likelihood of African American children to be investigated compared to Anglo children, which had risen steadily every year from 1.6 times more likely in 2013 to 1.9 times more likely in FY2017, from where it has remained steady in FY2018. African American children were 1.9 times more likely to be removed in FY2018, an increase from the relatively steady rates of between 1.6 and 1.7 times more likely seen between FY2013 and FY2017. Hispanic children are slightly less likely than Anglo children to be reported, investigated, or removed, while Other<sup>ii</sup> children are 2.3 times more likely to be reported, equally likely to be investigated, and slightly less likely to be removed compared to Anglo children. Overall disproportionality for Hispanic and Other children has remained relatively steady since 2013.

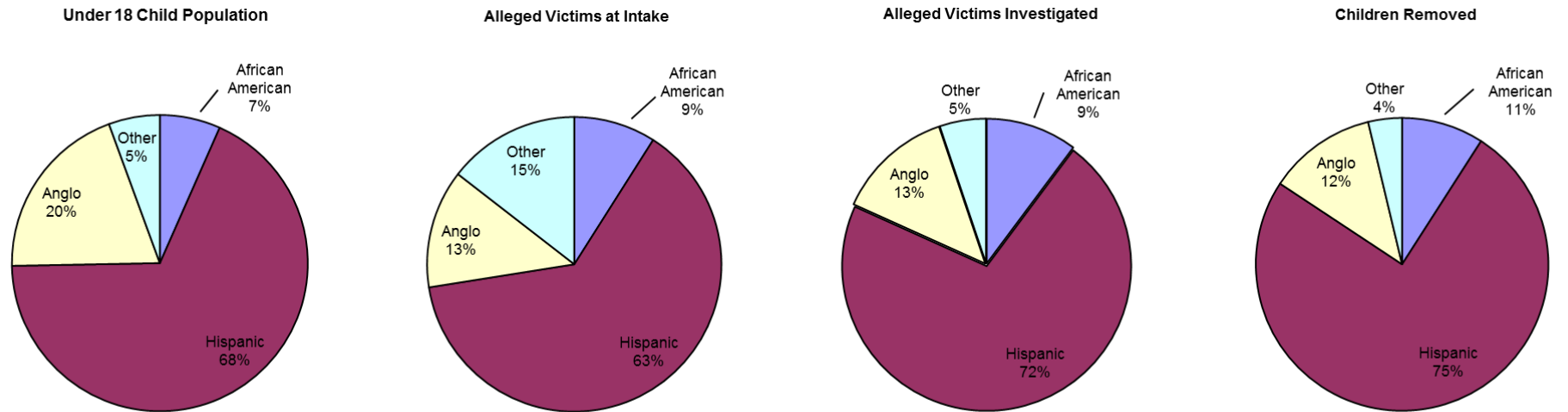
### County Analysis

African American children are 4.6 times more likely than Anglo children to have an allegation, 5.1 times more likely to be investigated, and 7.8 times more likely to be removed in Travis County, which is far above the state figures. Harris, Dallas, Tarrant, and Bexar counties show slightly higher disproportionality than the state for African American children reported, and investigated, though African Americans are 3.3 times more likely to be removed than Anglo children in Harris County, and between 2.3 and 2.4 times more likely to be removed in Dallas, Tarrant, and Bexar Counties in FY2018. Because 96% of the population of Hidalgo County is Hispanic, the figures are erratic.

While Hispanic children were less likely to be reported, investigated, or removed across the State, Hispanic children were 1.9 times more likely than Anglo children to receive an allegation, 2.2 times more likely to be investigated, and 2.3 times more likely to be removed in Travis County. Hispanic children were also more likely than Anglo children to be reported, investigated, or removed in Bexar and Hidalgo Counties in FY2018.

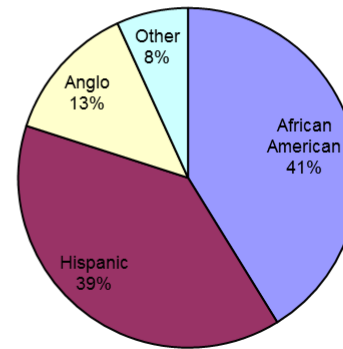

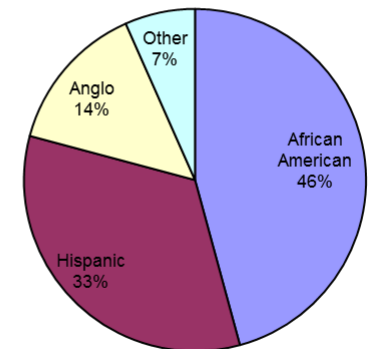
Alleged Victims at Intake

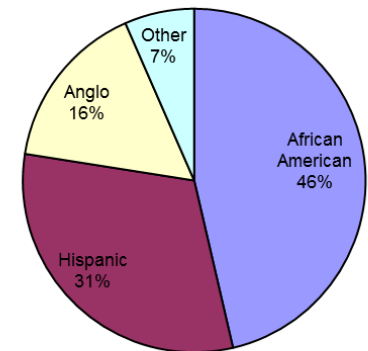
Alleged Victims at Intake

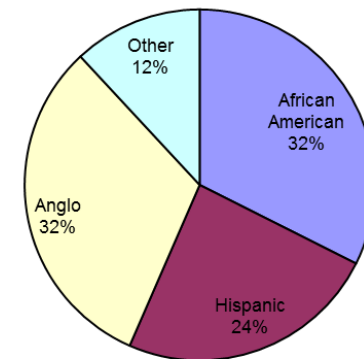
Alleged Victims at Intake

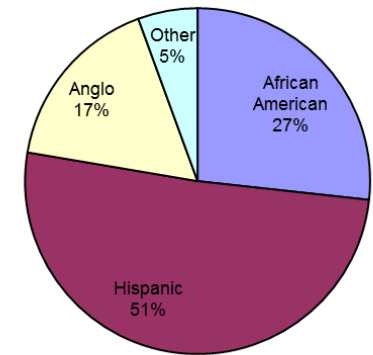
Alleged Victims at Intake

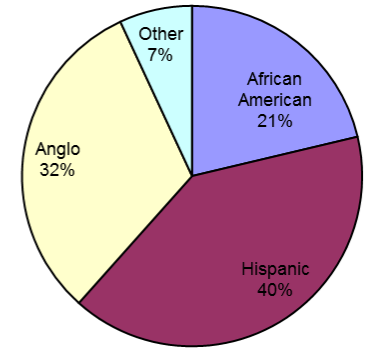
Alleged Victims at Intake
