

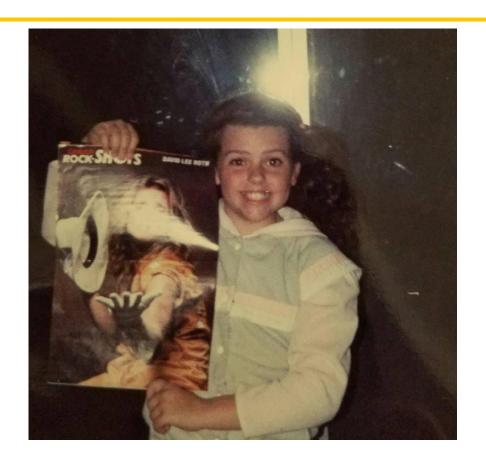

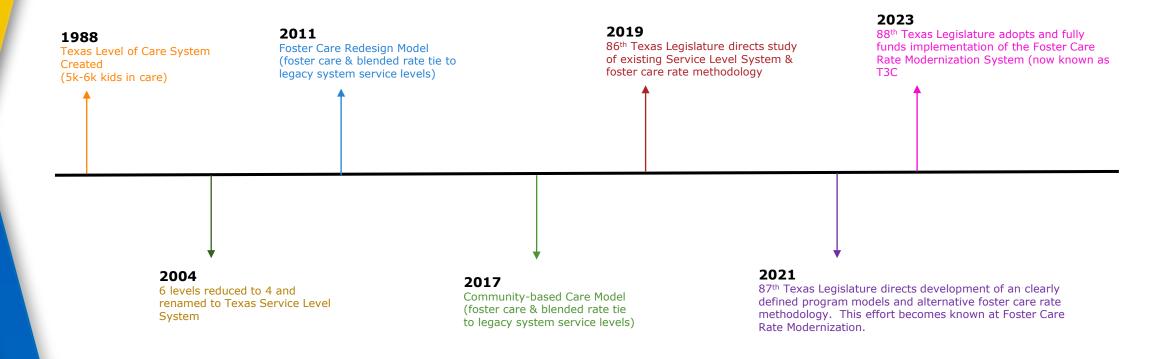
How Old is the Texas Service Level System?

36-Year History of Foster Care in Texas





Background

- 1. 86th Texas Legislature (2019, Regular Session), General Appropriation Act (GAA), Special Provision (SP) 32
 - ➤ Rate Methodology Evaluation; Third-Party Recommendations
- 2. 87th Texas Legislature (2021, Regular Session), GAA, SP26
 - ➤ Aligning Rates to Clearly Defined Program Models
 - Use CANS (and other tools) to inform placement and service decisions and track progress
- 3. 88th Texas Legislature (2023, Regular Session)
 - > Implementation of T3C



Historic Investment in Foster Care & Kinship Care Services

The 88th Legislature made a significant investment in improving the foster care system by increasing the biennial appropriation in SFY 2024-25 by an estimated \$149.5 million dollars, which includes:

- **\$49.6 Million in additional funding to sustain providers** at current payment levels by adopting a formal rate increase that offers a bridge between the current Service Level payment structure and the new modernized foster care continuum and rate structure.
- **\$30.6 Million in additional funding to increase the Basic, Moderate, and CBC blended rates**, this funding builds off the bridge for other services and levels by adding an increase for children with less acute needs to sustain providers and caregivers as the state transitions to the new foster care continuum and rate structure.
- **\$40.5** Million in additional funding to support the administrative costs related to the transition and implementation of a new foster care continuum and rate structure (T3C Implementation).
- > \$28.9 Million in additional funding to support new fully funded rates in SFY 2025 under T3C.
- **\$6.9** Million in additional funding to support concrete service needs and off-set costs incurred by relative caregivers as they care for children and work towards becoming a licensed foster parent.
- Increasing the daily payment to eligible kinship caregivers, so that it coincides with implementation of Foster Care Rate Modernization by raising the amount to fifty percent of the Basic foster family pass-through amount under the new rate structure. This will raise the rate from \$12.57 to \$23.45 per day beginning in January 2025.

Children's placements are defined by the services they need and the settings they will live in. DFPS purchases the service package in the setting. Payment doesn't change. As long as child needs that service package in that setting, payment remains the same.

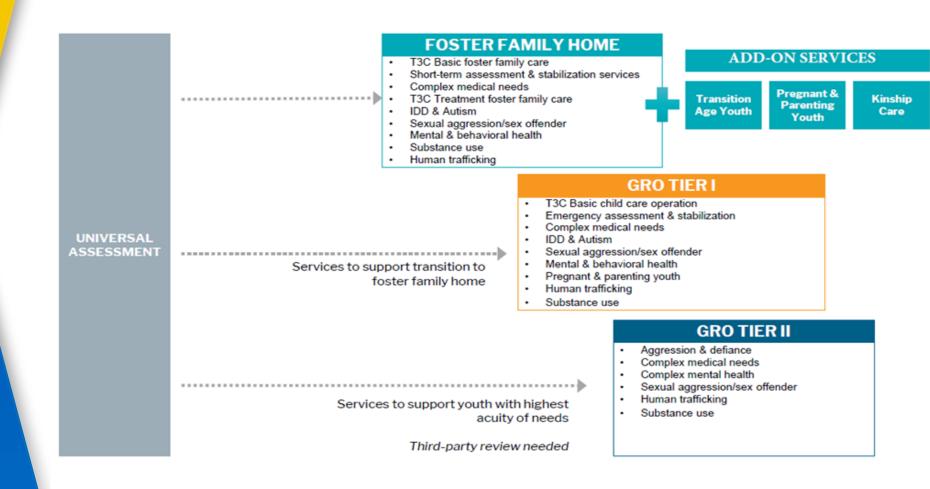


T3C System: Key Components

- ➤ Universal Screening and Placement Process
- ➤ 24 Clearly Defined Service Packages
- > Foster care rates that align with the cost of care
- > Continuous quality assurance and improvement structure
- > Structured transition/implementation plan

T3C System: Implementation Timeline & Update

Timeline for Transition:

- ➤ 11 months (January 2025) until transition of children begins under T3C System
- ➤ Transition period is anticipated to occur between January 2025 through August 2027
- ➤ September 2027 all children and providers will be served under T3C System (no more Service Levels)
