Extended Deadline: Texas Board of Legal Specialization (TBLS) Exam in Child Welfare Law – May 7, 2018 and Exam Fee Reimbursement

Applicants will be required to pay the application fee and examination fee in order to take the exam. Following successful completion of the exam, those who become Board Certified in Child Welfare Law will be eligible to receive reimbursement of the examination fee from the Children's Commission.
