



# Definition of Child Sex Trafficking Under Texas Law

Traffics	Causes	Commercial Sexual Exploitation
Traffics: <ul style="list-style-type: none"><li>• transports,</li><li>• entices,</li><li>• recruits,</li><li>• harbors,</li><li>• provides, <b>OR</b></li><li>• otherwise obtains by any means</li></ul>	<p><b>Through force, fraud, or coercion</b> causes the trafficked person to engage in (if victim is over 18)</p>	<ul style="list-style-type: none"><li>• Prostitution</li><li>• Promotion of prostitution (and aggravated)</li><li>• Online promotion of prostitution (and aggravated)</li><li>• Compelling prostitution</li></ul>
	<p><b>By any means</b> causes the trafficked child to engage in, or become the victim of conduct prohibited by (<i>no force, fraud or coercion required if victim is under 18</i>)</p>	Also includes additional conduct if victim is a child ( <i>continuous sexual abuse; indecency; sexual assault; sexual performance; employment harmful to children; child pornography</i> )

# Why screen for exploitation?

- Youth experience prolonged abuse because the problem remains hidden
  - For nearly 75% of exploited youth, abuse has been ongoing for 2+ years *before* referral to services.
- Most youth do not understand they are being exploited; self disclosure is rare
- Facilitates data-driven decision-making
- Ensures that there is *no wrong door* to identifying youth





# CSE-IT Development



- Gathered the input of 100+ stakeholders, including:
  - Wide range of providers
  - Survivors
- Wide geographic coverage across California
- Validated in 2016



# Universal Screening

- Screening is the first step in identifying risk
- Goals:
  - Prevention
  - Early intervention
- Everyone who meets pre-determined criteria is screened
  - CSE-IT: 10 years old and over
- Screening is *not* diagnostic

The CSE-IT is:


- An information integration tool

- Can be used in various systems and settings
- Is a research-based tool

# “Choice”...is Complicated

- What may seem like a “choice” might be:
  - *Trauma impacting the youth - feelings, behaviors, understanding, worldview (including sexually reactive behaviors)*
  - Youth trying to feel *power or control* in a situation
  - Youth trying to *make sense* of a difficult and confusing situation
  - The *exploiter influencing* the situation and understanding


# Youth who have been Commercially Sexually Exploited Generally Don't Outcry

# What is the CSE-IT?

# CSE-IT Rating Options

To be assigned to all ***Statements to Consider***

- **No Information** (0) – Not enough information to determine a rating at this time.
- **No Concern** (0) – Information suggests no concern is warranted at this time (“ruled out”).
- **Possible Concern** (1) – Watch and wait. Information indicates the problem is not serious or chronic or providers have some, but not all, of the information. Evidence of a past problem may also be rated here (a “historical 1”).
- **Clear Concern** (2) – Clear, concerning information determined from observations, report, or client records.



## Continuum of Concern


(draw a line indicating level of concern for exploitation)

# Commercial Sexual Exploitation Identification Tool (CSE-IT)

## Implementing the Tool



A “clear concern” score means that a child/youth meets criteria for mandatory reporting of suspected child abuse and service delivery, including referrals to Care Coordination, CSEY Advocate Services, and other specialized services available.



# Mandated Reporting

Human trafficking is a crime under international, federal, and many state laws.

If a mandated reporter *suspects* that a child is being commercially sexually exploited, a child abuse report *must* be filed.

- You do not need to know the name or age of the exploiter to report concern to DFPS.
- The exploiter does not need to live with the youth to report concern to DFPS.





## Even When Ready for Help, Trauma Makes Help Hard to Give and Receive

- Triggered by authority figures, telling their story, feeling rejected, power struggles, and random things like smells, locations
- Difficulty regulating affective impulses such as anger and self-destructiveness
- Dissociative episodes (mentally disconnect from body)
- Difficulty trusting people or feeling intimate
- Making choices that repeat destructive patterns
- Hopelessness or despair
- Somatic or medical problems
- A chronic sense of shame (blame self for victimization)

# CSE-IT TRAINING FOR LAW ENFORCEMENT AND CRIMINAL JUSTICE PERSONNEL

## OBJECTIVE:

Law enforcement and criminal justice personnel will have a shared language with Care Coordination Team partners and other service providers across the state when discussing children and youth who display a “clear concern” of experiencing commercial sexual exploitation; ultimately, understanding the indicators that are pointing to the need for investigation and prompting an investigation by investigative partners.

## CSE-IT TRAINING FOR LAW ENFORCEMENT AND CRIMINAL JUSTICE PERSONNEL

### STRATEGY:

- Regional Advisor Kellye Turner will provide CSE-IT training from a law enforcement perspective utilizing the WestCoast Children's Clinic (WCC) approved training curriculum.
- This training is eligible for 6 TCOLE training hours.
- Provide a minimum of 2 virtual CSE-IT for LE training sessions per year.
- Provide a minimum of 5 in-person CSE-IT training sessions per year (at least 1 in each CSTT region).




